Agenda:

1. Meeting: Called to order by Chair Johnson at 4pm.

2. Minutes: Minutes were sent by email prior to meeting. Motion made to accept the minutes by Com. Bleichner; 2nd by Treas. Wheeler. Motion passed.

- 3. Treasurer Report: The report was presented by Treas. Wheeler. He will be receiving the statement by email. The 2nd payment from the county will be coming.

 Motion made to accept the report by Com.Damrau; 2nd by Com. Dean Motion passed.
- 4. Pay Bills: Bills were presented by Adm. Kvidt. Motion by Com Bleichner to pay bills; 2nd by Com. Damrau. Motion passed.
- 5. Pumps: We currently have 1 1.5 HP Meyers Pump left in stock and 3 .5 HP Meyers Pumps in stock. We have replaced 14 pumps so far this year. All of our cluster systems use the 1.5 HP Pumps

Motion to approve the purchase of pumps as needed by Com Wheeler; 2nd by Com Damrau. Motion passed

- 6. Permits: We currently have 4 permits for active system replacements. In the last couple of months, we have replaced active systems at:
 - a. 34362 Deer Lake Road -bill paid at this meeting
 - b. 39364 Madsen Beach Road
 - There was an electrical wire broken during the crushing of the old tank that was not marked. Emil Electric spliced the wire back together and is sending the district a bill for this.
 - c. 36794 Augustana Loop -bill paid at this meeting
 - d. 38411 Wagon Trail Loop -bill paid at this meeting
 - e. 37930 Eldorado Beach Road
 - f. 40622 Holiday Trail -bill Paid at this meeting
- 7. 36520 Augustana Drive: Drainfield was no longer accepting water and must be replaced. This permit/design is out for bids now. This is included in the 4 permits we have for replacement above.
- 8. 38292 Eldorado Beach Road: the drainfield failed a compliance inspection and must be replaced. This is an active system. Ness Backhoe will be doing this install and this is included in the 4 permits listed above for replacement.

The homeowner is responsible for paying for the additional bedroom sizing on the drainfield.

- 9. Pumping: We pumped out the stilling tanks on our cluster drainfields at:
 - a. Drainfield west of Ottertail City on Highway 1
 - b. Drainfield in City Limits south of Ottertail City on Highway 78
 - c. Drainfield between Blanche and Ottertail Lake on Highway 78
 - d. Drainfield on Blarney Beach Road
 - e. Each of these stilling tanks had over 1 foot of sludge on the bottom the tank and this should be a part of the yearly cycle. It will help protect the drainfield from receiving anything other than effluent.
- 10. OTWMD manual: I have made a flash drive for every board member that has the current Otter Tail Water Management District Manual on it. I will pass them out to those that want one.
- 11. Nov meeting: Next month's meeting will be November 18th, 2020. This is the third Wednesday of the month. The second Wednesday of the month is November 11th, 2020 and is Veterans Day.

Administrator's Report:

- 1. 39609 & 39615 County Highway 1: These properties share a lift station on a cluster system. The alarm light went off on 9/12/2020. Hawes Pumped the tanks and I replaced on the pump on 9/17/2020.
- 2. 28676 County Highway 145: Alarm light came on 9/14/2020. I replaced the alarm float on 9/15/2020. This lift station is shared with 28690 County Highway 145. Other floats were operating as they should.
- 3. 42744 Pleasure Park Road: Service call on 9/15/2020. Septic tank and lift station were at the correct levels. Drainage issues in the house. It appeared to be an issue in the plumbing in the house or between the septic tank and dwelling.
- 4. 36520 Augustana Drive: Service call on 9/18/2020. Hawes pumped the tank that day. It appears the drainfield was not accepting water. We cameraed the line and found no root issues. This is a pre district system and appears to just be at the end of its life cycle. Active Maintenance system so the district will be replacing this. The design/permit is currently out for bids.
- 5. 36391 Segar Road: Loren received a service call on 9/21/2020. Alarm was going off, but pump was operating as it should. I replaced all three floats on 9/22/2020.
- 6. 39375 Clearmont Road: Failed compliance inspection on 9/30/2020. Passive System. Homeowner is responsible to bring into compliance.
- 7. Quite a few new installs and compliance inspections in the last month.

- **6.** We currently have 4 permits for active system replacements. In the last couple of months, we have replaced active systems at:
 - a. 34362 Deer Lake Road-bill paid at this meeting
 - **b.** 39364 Madsen Beach Road
 - There was an electrical wire broken during the crushing of the old tank that was not marked. Emil Electric spliced the wire back together and is sending the district a bill for this.
 - **c.** 36794 Augustana Loop-bill paid at this meeting
 - **d.** 38411 Wagon Trail Loop-bill paid at this meeting
 - e. 37930 Eldorado Beach Road
 - **f.** 40622 Holiday Trail-Bill Paid at this meeting
 - We are still waiting on a couple of these bills to come in. We also are waiting on bills from electricians on some of these installs for wiring in the septic pumps.
- **7.** 36520 Augustana Drive: Drainfield was no longer accepting water and must be replaced. This permit/design is out for bids now. This is included in the 4 permits we have for replacement above.
- **8.** 38292 Eldorado Beach Road: the drainfield failed a compliance inspection and must be replaced. This is an active system. Ness Backhoe will be doing this install and this is included in the 4 permits listed above for replacement.
 - **a.** The homeowner is responsible for paying for the additional bedroom sizing on the drainfield.
- **9.** Transferred money to the Tanks and Lines Checking Account: \$15,000
- **10.** We pumped out the stilling tanks on our cluster drainfields at:

 - c. Drainfield between Blanche and Ottertail Lake on Highway 78
